#### VIII. REPORTS

- A. Report of the Fire Chief Fire Chief Don Lombardi
  - 1. US&R Update

The administrative readiness evaluation (ARE) scheduled for July 30 and 31, 2019, will be rescheduled for September 24 and 25, 2019, due to the death of a FEMA staff member that would have been one of the leads.
