VIII. REPORTS

- A. Report of the Fire Chief Fire Chief Don Lombardi
 - 1. COVID-19 Update

We remain prepared to meet the ongoing needs of the COVID-19 pandemic. While Colorado is seeing a decline in cases, and while many people in the community are beginning to participate in gatherings and demonstrating a lack of social distancing, we are still in the middle of a pandemic and must remain ready to respond. The Incident Management Team (IMT) has been disassembled, leaving a more traditional response in place to handle the ongoing needs of the pandemic. In recent weeks, Medics 9 and 17 have been utilized as in-service resources when staffing allows. Division Chief Bob Olme has been very successful in securing personal protective equipment, including a stock of gowns and coveralls in preparation for a possible second surge in the coming months. COVID-19 reimbursement efforts are underway through FEMA, the CARES Act, Health and Human Services, the state, and county. Revenues remain steady at this time. We continue to monitor COVID-19 and its impact in the community.

2. Accreditation Update

a. Annual Compliance Report (ACR)

The ACR, which is intended to show the annual progress that is made toward continuous improvement throughout a 5-year

accreditation cycle, is almost complete. It will be submitted by mid-July.

b. Documents Discussion

In addition to the ACR, Chief Lombardi briefly discussed the documents which make up the four pillars of the accreditation process. The West Metro Risk Assessment, Standard of Cover, Strategic Plan, and Self-Assessment are comprehensive documents designed for quality improvement in West Metro's response to the community. 3. Finance Division Update

a. April 2020 Financial Statements

Ms. Aragon reviewed the April 2020 financial statements which will be brought to the board for approval at the July meeting.

B. Administration – Deputy Chief Mark Krapf

Mark Nava, Jeffcom Dispatcher, has been selected to receive the prestigious Association of Public-Safety Communications Officials International - Tele-Communicator of the Year award. Congratulations to Mr. Nava for this well-deserved honor.

C. Operations – Fire Chief Don Lombardi

1. Review of Recent Activities

Chief Lombardi briefed the board on a birthday party drive-by event for a child with muscular dystrophy, which is an example of one way in which the crews have remained engaged with the community during this time of COVID-19.

D. Life Safety – Deputy Chief Bruce Kral

Comprehensive Electronic Report

West Metro has worked with counties and municipalities to permit local restaurants to expand seating into the sidewalks and streets to accommodate appropriate social distancing, while maintaining appropriate access for emergency response.

With the July 4th holiday approaching, Chief Kral mentioned that neighborhoods requesting apparatus participation in neighborhood parades will be asked to display West Metro's Safe 4th of July Celebration signage in advance of the event. The administrative building has begun to slowly reopen with select small classes and meetings in large meeting spaces to allow for social distancing.

1. July Board Meeting

The July 21, 2020 board meeting will be an in-person meeting. Special arrangements will be made to accommodate sanitation and social distancing.

2. Board Retreat

The board retreat will be held on Friday, July 31 in the afternoon and all day on Saturday, August 1 at the Training Center. Chief Lombardi asked the board members to save these dates.

3. Workplace Respect Update

Chief Lombardi displayed a video that he and President Mulcahy recently produced, which was a short video-conversation in response to the recent civil unrest and volatility across the country, and to continue the conversation and ongoing commitment to respect in the workplace. The video was distributed to the entire organization via Target Solutions. President Mulcahy commented on some of the productive conversations that have occurred since the release of this video.
